**Grant Application 2021-2022**

Thanks to generous gifts from saints throughout the ages, Resurrection Lutheran Church (RLC), through its Mission Endowment Fund, is blessed to provide grants to ministries in our community and throughout the larger Church. We welcome you to apply for a grant.

We provide grants to support ministries of our community, the Evangelical Lutheran Church in America, Resurrection Lutheran Church, and others as appropriate. Grants average \$1,500-2,000.

Completed applications must be received by 5:00 PM (CST), Friday, December 3, 2021. We will notify all applicants of our decisions and award grants by early January 2022.

Grantees agree to submit photos with captions. Additionally, grantees are asked to publicize information about the grant received by including an appropriate description in the organization's print or electronic publications, such as an annual report. We also ask that all grant recipients share the good news using social media whenever possible.

Grantees will be invited to RLC on Sunday in 2022 to share stories and information with our congregation and community. Our committee will be in touch in the early Spring to schedule a time for you to visit us in person or virtually. There is a possibility of a Mission Endowment Fund Fair in March should it be safe to have one.

Organizations must be a recognized 501(c)(3) in good standing or a ministry of a congregation in the United States.

**INSTRUCTIONS:**

1. Complete and sign the Application Cover Sheet.
2. In **no more than 2 pages**, describe the program or project for which this grant will be used, including:
  - A description of the project and its goals,
  - Description of the community your project is trying to impact and its location,
  - The needs or opportunities to be addressed,
  - The specific outcomes that are expected to occur as a result of this grant,
  - How you will evaluate success, and
  - Your organization's mission and qualifications to undertake this project, including the qualifications of the person overseeing the effort.
3. Provide project and organizational budgets. The budgets should differentiate between funds that are committed and those that may come from potential funding sources.
4. You may provide supporting materials (photos, articles, letters of support) if you believe it will strengthen your application. This is optional.
5. Submit application electronically to office@rlclakeview.com in *as few attachments* as possible.
6. **Completed applications must be received by 5:00 PM (CST) December 3, 2021.**
